## Introduction

The **Level 2 Award in Understanding the PREVENT and Safeguarding Strategies** is aimed at everyone who has a responsibility to help safeguard young people and help to prevent their radicalisation. It demonstrates that individuals understand the purpose of the Prevent Strategy and radicalisation, helping to safeguard children and young people.

The Regulated Qualifications Framework is the single framework for regulated qualifications, the regulatory body for this qualification is the Office of Qualifications and Examinations Regulation (Ofqual).

The registration and certification fee for this qualification includes candidate access to a high impact **learning resource** which has been developed by one of our partners within the movie industry. An assessment resource and supporting materials are also provided to approved centres.

The use of these learning and assessment resources is not mandatory, centres may use a delivery mechanism appropriate to their centre and their candidates.

### Staff

### Assessors/Internal Quality Assurance

## Assessment

Candidates must demonstrate the level of knowledge and/or skills described in the unit. Assessment is the process of measuring a candidate's knowledge and understanding against the standards set in the qualification.

Each candidate is required to produce evidence which demonstrates their achievement of all of the learning outcomes and assessment criteria for each unit.

Evidence can include:

- assignments/projects/reports
- worksheets
- portfolio of evidence
- record of oral and/or written questioning
- candidate test papers

**Learning outcomes** set out what a candidate is expected to know, understand or be able to do. **Assessment criteria** specify the standard a candidate must meet to show the learning outcome has been achieved.

**The PREVENT/Safeguarding film learning resource** which incorporates all of the learning outcomes of the qualification and addresses all of the qualification assessment criteria, along with supporting resources and an assessment workbook are provided to approved centres. Access to this resource is included in the candidate registration and certification fee.

Use of the film, supporting resources and assessment material is optional - centres can use their own delivery and assessment materials to confirm that candidates meet all of the requirements of the qualification.

## **Internal Quality Assurance**

An internal quality assurance verifier confirms that assessment decisions made in centres are made by competent and qualified assessors, that they are the result of sound and fair assessment practice and that they are recorded accurately and appropriately.

## **Adjustments to Assessment**

Adjustments to standard assessment arrangements are made on the individual needs of candidates. ProQual's Reasonable Adjustments Policy and Special Consideration Policy sets out the steps to follow when implementing reasonable adjustments and special considerations and the service that ProQual provides for some of these arrangements.

## **Certification**

#### **Claiming certificates**
