## Introduction

The purpose of the **Level 4 Certificate for Police Alcohol Licensing Officers qualification** is to provide a formal professional policing qualification for the Police Alcohol Licensing Officer. The qualification will form part of an annual CPD programme that underpins a licensing officer's competence and currency.

The content has been researched and prepared in association with relevant professional bodies and reflects police-led safer licensing initiatives as well as Government policy and best practice. Topics covered include legislation underpinning the Alcohol Licensing process, the role of partners within the process, conducting a Premises License Inspection and a Review, and the role and responsibilities of the Police Licensing Officer.

This qualification has been created on behalf of and in consultation with the National Police Chiefs Council (NPCC) Portfolio Holder for Alcohol Licensing and Harm Reduction. This follows the designation by the NPCC of the Police Alcohol Licensing Officer role as being a professional policing role.

The Regulated Qualifications Framework (RQF) is the single framework for regulated qualifications, the regulatory body for this qualification is the Office of Qualifications and Examinations Regulation (Ofqual). This qualification is accredited onto the RQF.

### Staff

Staff delivering this qualification must be appropriately qualified and/or occupationally competent.

### Assessors/Internal Quality Assurance

Assessors for each unit must have verifiable, current industry experience and a sufficient depth of relevant occupational expertise and knowledge and must use a combination of assessment methods as defined in the Consolidated Assessment Strategy.

Assessors and internal quality assurance verifiers for competence-based units or qualifications will normally need to hold appropriate assessor or internal quality assurance qualifications.

## Support for Candidates

## Assessment

This qualification is competence-based, candidates must demonstrate the level of competence described in the units. Assessment is the process of measuring a candidate's skill, knowledge and understanding against the standards set in the qualification.

Each candidate is required to produce evidence which demonstrates their achievement of all of the learning outcomes and assessment criteria for each unit.

Evidence can include:

- Observation report by assessor
- Assignments/projects/reports
- Professional discussion
- Witness testimony
- Record of oral and written questioning
- Recognition of Prior Learning

**Learning outcomes** set out what a candidate is expected to know, understand or be able to do.

**Assessment criteria** specify the standard a candidate must meet to show the learning outcome has been achieved.

## Internal Quality Assurance

An internal quality assurance verifier confirms that assessment decisions made in centres are made by competent and qualified assessors, that they are the result of sound and fair assessment practice and that they are recorded accurately and appropriately.

### Claiming certificates

### Unit certificates

### Replacement certificates

If a replacement certificate is required a request must be made to ProQual in writing. Replacement certificates are labelled as such and are only provided when the claim has been authenticated. Refer to the Fee Schedule for details of charges for replacement certificates.
