Introduction

The ProQual Level 2 NVQ Diploma in Demolition (Construction) qualification provides a nationally recognised qualification for those working in this specialised area of construction. There are 2 specialised pathways:

Pathway 1 – Demolition and Refurbishment Operative Pathway 2 – Plant Operative

The awarding body for this qualification is ProQual Awarding Body (<u>www.proqualab.com</u>) and the regulatory body is the Office of Qualifications and Examinations Regulation (Ofqual); It is also endorsed by the sector body for construction - CITB.

The qualification replaces 603/0511/3 ProQual Level 2 NVQ Diploma in Demolition (Construction), following an industry review, and has been accredited onto the Regulated Qualifications Framework (RQF) and is published on Ofqual's Register of Qualifications.

Evidence can include:

- professional discussion
- witness testimony
- candidate product
- worksheets
- record of oral and written questioning
- Recognition of Prior Learning

Learning outcomes set out what a candidate is expected to know, understand or be able to do.

Assessment criteria specify the standard a candidate must meet to show the learning outcome has been achieved.
