Introduction

The qualification is aimed at individuals who have an interest in the Machine method of micropigmentation (Cosmetic Tattooing) for the face and scalp, and for individuals who work within the beauty industry and want to expand their talents or upgrade their existing certification to a regulated qualification certificate. Candidates learn about Health and Safety, Personal Protection, Consultation techniques, Colour Theory, Pigments for Face and Scalp, Equipment and Needle Choice, Tattooing Techniques for eyebrows, eyeliner, lips & scalp, Aftercare and Follow-up.

The awarding organisation for this qualification is ProQual Awarding Body and the regulatory body is the Office of Qualifications and Examinations Regulation (Ofqual).

Entry Requirements

Candidates are required to have achieved a Level 3 qualification in this area of beauty, or hold certificates that have relevancy from prior learning.

Centres should carry out an **initial assessment** of candidate skills and knowledge to identify any gaps and help plan the assessment.

Each candidate is required to produce evidence which demonstrates their achievement of all of the learning outcomes and assessment criteria for each unit.

Evidence can include:

- record of oral and/or written questioning
- candidate test papers

Learning outcomes set out what a candidate is expected to know, understand or be able to do. **Assessment criteria** specify the standard a candidate must meet to show the learning outcome has been achieved. *Learning outcomes and assessment criteria for this qualification can be found from page 7 onwards.*

In order to demonstrate competence there must be evidence that the candidate has carried out the procedure for:

(a) **TEN** different clients covering the range of:

- eyebrows
- strokes and powder effect
- eyeliner and eyelash thickener
- lip liner and full lip colour

(b) **THREE** different clients covering scalp pigmentation

Internal Quality Assurance

An internal quality assurance verifier confirms that assessment decisions made in centres are made by competent and qualified assessors, that they are the result of sound and fair assessment practice and that they are recorded accurately and appropriately.

Adjustments to Assessment
